Every mother wants to give her baby the best prenatal care available.

Half of Georgia's births are covered by Medicaid. Medicaid means pregnant women receive regular checkups and necessary prenatal care to ensure healthy babies. Having this health coverage prevents a soon-tobe mom from worrying about health care costs while planning for the birth of her child.

MEDICAID COVERAGE ALLOWS MOMS TO TAKE THEIR KIDS TO THE DOCTOR WHEN NEEDED.

When it comes to a "boo boo," there's no medicine like Mom's kisses. Yet, Medicaid coverage is essential to providing children with the primary health care they need—from flu shots to broken bones. When children get sick

unexpectedly, having healthcare coverage can help them get better quicker, which means they get back to school and Mom gets back to work. Plus, Medicaid has long-term benefits for kids. Studies have shown that children with Medicaid coverage become healthier adults and have higher incomes.

a disability so that they can be there for their children.

Anthony was adopted when he was six and his brother Nicholas when he was three weeks old. Their mother Hannah says "the foster-toadoption Medicaid program made sure that finances never weighed on our minds. We could focus all our energy on providing a loving family instead of scrambling to pay medical bills. Both **Anthony and Nicholas** rely on Medicaid for physical and psychological therapy as well as medication.

MEDICAID MEANS MOMS AGE WITH DIGNITY. Our mothers took great care of us, so now we want to return the favor by taking care of them as they age. When elderly parents need long-term care, the costs are high and often not covered by Medicare. Medicaid coverage ensures that our mothers (and fathers) are provided for as they get older, without having the huge out-of-pocket financial burden of paying for their health care.

Medicaid helps pay for 3 out of 4 nursing home stays in Georgia.

mother wants to be the best mom she can be for all of her children. The mother of a child with disabilities carries an extra sense of responsibility to ensure that her child

can grow up to be a healthy and thriving adult. Disability care costs can impose a monumental level of financial stress on a family. Medicaid helps to relieve the financial burden and promote a healthier home by providing healthcare coverage for children with disabilities. That includes community-based services like in-home nursing care for children with disabilities to help parents continue working so they can continue to provide for the whole family.
