Re: Rural Hospital Stabilization Committee

Dear Senator Lucas and Representative England:

Thank you for your commendable service on the Rural Hospital Stabilization Committee. We are writing on behalf of the Georgia Budget and Policy Institute, Georgia Watch, Georgians for a Healthy Future, Families First, and eleven additional organizations. All of these organizations are committed to ensuring access to quality, affordable health care for all Georgians. As such, we have been monitoring the Rural Hospital Stabilization Committee meetings and wish to supply some input to help in your efforts to find solutions for rural hospitals in Georgia.

We encourage the Committee to consider recommending to the Governor and the Georgia Legislature that they accept federal funding to expand Medicaid eligibility to Georgia's poor and low-income adults. Georgia's rural hospitals are struggling under the burden of uncompensated care, the uncertainty of impending Disproportionate Share Hospital (DSH) payment cuts, and other policies that make it hard to operate competitively. By expanding Medicaid eligibility, and thus providing more than 400,000 Georgians with health insurance, rural hospitals would be able to collect compensation for the care that they are currently providing to their patients at no cost. Hospital revenue would increase, off-setting the need for DSH payments. The additional income would boost hospital revenues, thus strengthening the financial situations of rural hospitals and Georgia's health care system as a whole. Hospitals in states that have expanded their Medicaid programs are already reaping the benefits of expansion, including large savings in uncompensated care costs and more robust revenues. Closing the coverage gap by expanding Medicaid eligibility is an important part of maintaining the vital health care infrastructure in rural Georgia. Please find attached our full report.

Thank you for considering consumer input in the Rural Hospital Stabilization Committee's work. We share the Committee's goal of supporting and stabilizing rural hospitals so that all Georgians have access









to health care close to home. We hope that the Committee will recommend the expansion of Medicaid eligibility as a strategy for saving Georgia's rural hospitals.
