## 2024 EVENTS RECAP





#### < 2024 Health Care Unscrambled

Our 14th annual Health Care Unscrambled event brought together state legislators, national experts, and community advocates to discuss critical health policy issues. The dynamic legislative panel, featuring Sen. Sonya Halpern, Sen. Ben Watson, and Rep. Sharon Cooper, tackled topics like Medicaid challenges, hospital oversight, and maternal health.

The keynote panel with Dr.
Joan Alker and Dr. Alex
Briscoe focused on changes
in the Medicaid landscape
and how that impacts
children's health. The event
successfully fostered bipartisan dialogue and spotlighted
constructive policy solutions
that would improve health
and well-being for Georgians.

#### 2024 Advocacy Day >

In February, GHF hosted Cover Georgia's Advocacy Day at the Capitol, rallying Georgians to speak out in support of Medicaid expansion. This event amplified the voices of uninsured Georgians who are stuck in the coverage gap and underscored the urgent need for action by state leaders.









#### Celebration of Progress & Possibilities >

In September, GHF held its first Celebration of Progress & Possibilities event to recognize and celebrate the hard work of advocates and state leaders in advancing policies and systems that build a healthier Georgia. Dr. Natalie Hernandez, Executive Director of Morehouse School of Medicine's Center for Maternal Health Equity, shared her reflections from more than a decade of partnership and collaboration with GHF. This event honored the collective efforts that are driving positive change in our state.









#### Navigator Program: Community Events

GHF's Health Insurance Navigator program provided free assistance to individuals and families across Georgia. Through community-based outreach and empathetic help, GHF's navigators helped Georgians navigate the complexities of Medicaid during the Medicaid unwinding and private health insurance as the new Georgia Access marketplace replaced healthcare.gov. Navigators play an important role in assisting uninsured residents across the state, particularly in under-

served communities. The program, supported by the Georgia Department of Insurance, connects directly with communities through in-person outreach and local events. Navigators attend and coordinate numerous community events each month, meeting people where they are—in neighborhoods, YMCA locations, schools, and cultural centers—to provide one-on-one assistance and clear guidance on health coverage options.

## POWERED BY PEOPLE!

### Continuing the march towards Medicaid expansion

In 2024, GHF continued our fight for Georgians across the state to ensure that no one's health is hampered by where they live, who they are, or how little money they make.

» A Leading Voice GHF stood firm as one of the leading voices urging state leaders to choose Medicaid expansion so that low-income adults have health insurance and access to care when they get sick and to keep them healthy.

#### » Georgia Legislative Session

Jan.-March 2024: During the state's legislative session, GHF collaborated with state leaders and partners to make Medicaid expansion part of the heated discussions about hospital regulations and reforms and to shape a key bill that led to Georgia's first-ever legislative committee hearing on Medicaid expansion.

As a result of GHF's work and partnerships and your advocacy:

 A Senate committee held Georgia's first-ever legislative committee hearing to close the coverage gap. GHF's Executive Director Laura Colbert provided expert testimony on the need for and benefits of expanding coverage, helping state leaders understand why Medicaid expansion is the right choice for our state.

- The Comprehensive Health
   Coverage Commission (CHCC)
   was stablished by HB 1339. The
   CHCC is charged with examining
   opportunities to improve access
   to and quality of health care for
   low-income and uninsured
   Georgians, and sharing recommendations with Governor Kemp
   and the General Assembly. The
   Commission will continue to meet
   in 2025 and 2026, so keep up
   with their activities and how you
   can participate at CoverGA.org!
- » Coverage Captains GHF launched our new Coverage Captains initiative to connect with more Georgians about Medicaid expansion. Coverage Captains are local community members who receive training and support from GHF to raise awareness about the need to close Georgia's coverage gap and to mobilize their local communities to support expanding Medicaid. In the first five months of the program, four Coverage Captains reached more than 1000 Georgians!

#### Paul Mikell

"I just wanted to see a doctor when I got sick. But the paperwork made it feel impossible."

Paul Mikell, an essential worker from South Georgia, spent months trying to enroll in Medicaid through Georgia's new Pathways to Coverage program. Though eligible, he faced confusing updates, delays, and dead ends. When he finally cleared the red tape, Paul could affordably see a doctor again—for the first time in a long time.


His story highlights the needless complexity of Georgia's current system—and the difference that full Medicaid expansion could make for thousands more just like him.

## POWERED BY PEOPLE!

#### **Healthy Housing**

Stable, affordable housing is foundational to health—and at GHF, we advocate for systems that make health possible beyond the doctor's office. GHF grew our Healthy Housing work by collaborating with a coalition of partners to secure three key policy wins:

>> Pay raises for Direct Support
Professionals Direct Support
Professionals (DSPs) support people
with disabilities so they can live
healthily and independently at
home. Pay raises were one of the
policy recommendations that GHF
called for in our 2022 "Realizing the
Promise of Olmstead" report.



>> Safe at Home Act The Safe at Home Act (HB 404) protects Georgia renters from unhealthy housing conditions and unfair eviction practices. GHF mobilized hundreds of Georgians in support of HB 404.

» Protect the Low Income Housing

Tax Credit The Low Income Housing Tax Credit (LIHTC) is a federal subsidy program that motivates investors and developers to build housing that is affordable to low- and modest-income families. Georgia matches 100% of the federal LIHTC, which GHF advocated to protect and maintain.

- >> Educational materials GHF produced several educational materials to help educate state leaders and every-day Georgians about important housing programs, why they're essential to the health of Georgia families, and the policy actions needed to support them:
- Georgia Housing Voucher Program
- Georgia's Low Income Housing





## New! Partnering with caregivers:

GHF secured modest grant funding to partner with family caregivers, increasing awareness of their value to Georgia's health care and public health systems, identifying public policy opportunities to support their (usually unpaid) work, and elevating their voices in policy decisions.

#### Sherthea Jackson

"It's a two-hour drive each way just so my kids can see the doctor they need."

For Sherthea Jackson, a mother navigating Georgia's Medicaid system, specialist care for her children comes with a heavy price: time, travel, and uncertainty. Rural doctor shortages mean that what should be routine care becomes a full-day journey. Her story is a powerful reminder that even when coverage exists, access does not always follow—and why GHF continues to push for policies that connect Georgians to care where they live.

#### Moving Mental Health Forward

In 2024, Georgians for a
Healthy Future continued to
support and promote the 2022

Act with the goal of maximizing the law's benefits for
Georgians and their families.

» Georgia Mental Health Parity Day GHF co-hosted the first annual Georgia Mental Health Parity Advocacy Day at the Capitol.

#### » Partnership with the Carter Center

GHF collaborated with The Carter Center to launch a new consumer awareness campaign to help Georgians understand their rights and protections under the law and how to ensure their mental health care was covered as much as possible.

GHF leaders attended community roundtables in Albany and Savannah to hear feedback from community members about the campaign so it can be improved for future use.



#### **»** Promoting Consumer Rights

Also in collaboration with The Carter Center, GHF briefed officials at the Georgia Departments of Community Health and Insurance about how to improve implementation of the state parity law. GHF's work led to improvements in the information that the Department of Community Health shares with Georgia consumers about their parity rights and protections.

## Watching out for Georgia consumers

After GHF called on the Georgia Department of Insurance to protect Georgia consumers from two health insurance enrollment companies that were identified as bad actors, DOI suspended the two companies from participating in the new Georgia Access marketplace. This protected Georgians from possible fraud and scams as they enrolled in health insurance.

#### Jessica Swillings

"Without Medicaid, I couldn't have gotten through my pregnancy, let alone my recovery."

For Jessica Swillings of Sanders-ville, Medicaid didn't just cover her medications—it kept her on the path to healing. As she navigated co-occurring mental health and substance use challenges, the support she received from Medicaid—especially during pregnancy—meant one less thing to worry about. No stress about how to pay for medications. No skipped appointments due to lack of transportation.

Jessica knows her story is a hopeful one, but not everyone is so lucky. That's why she speaks up—to close the coverage gap and help more Georgians get the care they deserve.

## LOOKING AHEAD

While there is a lot to celebrate from 2024, we are clear-eyed about the challenges that surround Georgians in 2025. Proposed policy changes from Congress and sudden, seismic reshapings of the federal public health workforce and federal funding endanger many of the policies and programs that Georgians (sometimes unknowingly) rely on for our health, health care, and health coverage. In the face of such threats, GHF remains committed to doing what's right for the most important people in our state–Georgians and our families.

We remain steadfast in our vision of a Georgia where all residents have equitable opportunities to achieve their highest level of health.

To keep that vision as close as possible, GHF will continue to:

- » Listen closely to and amplify the voices of rural Georgians; Black and brown Georgians; low-income families; people with disabilities and chronic conditions; and any Georgian shouldering the burdens of unfair health care and coverage systems;
- » Build understanding among leaders and Georgians who do not yet support the public policies needed to realize a healthy, thriving Georgia;
- » Collaborate with partner organizations and community members to effectively maximize our collective expertise, skills, and resources for the benefit of Georgians; and
- » Loudly call for the evidence-based policy solutions that will best support and improve the health and well-being of Georgians.

We ask you to walk alongside us in these challenging times, just as you have when progress came easier.



#### Meet the 2024 GHF team

In fall 2024, GHF completed an organizational expansion (from 7 staff members to 10) and restructuring process. The process strengthens our ability to carry out high-quality advocacy and programmatic initiatives, and more effectively lead policy change for Georgians.
